The collection consists of two letters written by Austin David Thompson, 16th Connecticut Volunteer Infantry, to his fiancée, Electa Churchill, in the spring of 1863. Both letters were written while Thompson's regiment was in Newport News, Virginia. The later one has an illustration of the "Encampment of U.St. Troops at Newport News, VA" as the letterhead.

## **BIOGRAPHICAL/HISTORICAL SKETCH**

Austin David Thompson, (b.1841), served with Company K 16<sup>th</sup> Connecticut Volunteer Infantry. Residence, Bristol, Connecticut. Enlisted August 11, 1862; mustered as private

August 24, 1862. Promoted to Corporal 1863 and to Sergeant in 1864. Captured at Plymouth, NC, April 20, 1864; Parole date not known; Discharged June 8, 1865.

### **SERIES DESCRIPTION**

The Austin Thompson Papers are in a single series. The material is arranged in ascending chronological order.

**Series I: Correspondence.** Comprised of two letters from Austin Thompson to Electa his. This is series housed in 2 folder files arranged chronologically.

**Folder 2** Correspondence, February 1863

February 2, 1863. 3-page letter to Electa Churchill (his future wife). Expresses his longing to be with her and briefly describes campground as “the most pleasant place that we have ever been in since I enlisted.” Writes that Oysters cost 25 cents a quart.

**Folder 3** Correspondence, March 1863

March 4, 1863. 3-page letter to Electa. Letterhead has large engraving entitled *Encampment of U.S.T. Troops At Newport News, VA*. Extra small print below pictures states *Entered according to an Act of Congress in the year 1861 by C. Bohn, in the Clerk’s Office of the D.C. and Publ. by C. Bohn, Washington D.C.* Thompson details the duties of an orderly and his plans to visit Fort Monroe. Describes punishments occurring in camp.
