#### This sample language may be useful for making an unrestricted bequest:

#### Sample language to establish an endowment for specific purposes:

**Important Note**: If you do specify a use for your bequest, the following language will ensure that your gift will always remain productive: "If at any time in the judgment of the Trustees of The Mariners' Museum and Park the designated use of this bequest is no longer practicable or appropriate, then the Trustees shall use the bequest to further the general purposes of the Museum, giving consideration, where possible, to my special interest as described [above][below][in \_\_\_\_\_\_]."
